



# PROJECT EXCELLENCE AWARDS **2025**

NAWIC is dedicated to honoring best in class construction projects and the firms, companies, and teams that design and build them. The categories for the projects are: **Civil/Heavy Highway, Commercial, Institutional, and Residential.**

An independent jury of industry professionals in design and construction will judge the projects using seven criteria (listed below). Winners will be announced and honored at the Awards Luncheon at NAWIC's Annual Conference in Boston, MA on Friday, August 22, 2025.

## ELIGIBILITY

- The project must be built in any of the 50 U.S. states including Washington D.C. and U.S. Territories
- Substantial completion must be executed between January 1, 2024 and December 31, 2024.
- A project with a construction-related fatality, regardless of contractor or trade, is not eligible.
- There is no limit to the number of projects each firm or person can submit.
- One project per application

## JUDGING CRITERIA

Eligible projects are reviewed by a panel of judges, which will award projects based on the following criteria:

- Collaborate. Entries may be submitted by any of the firms working on the project, but the most successful entries are joint entries incorporating input from multiple key team members, such as the design firm, contractor and owner.
- Visuals matter and are a great way to magnify the impact of your submission.
- Verify that your project meets all requirements (including word counts and deadlines) before final submission.

## Project Excellence Awards Categories

**COMMERCIAL**– Projects that involve renovation or new construction of a business or venture that is done with the sole motive of gaining profit.

**RESIDENTIAL** - Projects that involve renovation or new construction of individual and multi- family dwellings.

**CIVIL / HEAVY HIGHWAY** – Large, public infrastructure projects

**INSTITUTIONAL**- Projects that involve renovation or new construction of any structure that fulfills a role related to healthcare, recreation, or public works.

## JUDGING CRITERIA

**Project Overview**- In 500 words or less, please give an overview of the project.

General description (not to exceed 100 words) for the following criteria:

**Innovation**- Please describe any new methods, ideas, or products used in this project.

**Safety**- What steps were taken to make sure everyone involved with this project was safe.

**Sustainable Practices**- Please describe ways in which this project supported ecological, human, and/or economic health and vitality.

**Budget/Value**- What was your original budget? What did your team do to stick to that budget or make sure that if you went over, it was adding value to the project? What was your final budget?

**Unique/Additionally Notable/Misc.**- Please describe anything else you want to add about your project. Was there anything you did that makes it stand out from other projects?

**NAWIC Affiliations, if applicable** - List any NAWIC members or member companies affiliated with this project
